PRESIDENT'S MESSAGE CONTINUED

Our Chiniak planting program is on track with our seedling planting for the 2023 season. As of this writing, over 144 acres with nearly 73,000 seedlings have been planted this year. That brings the total number of seedlings planted to date at over 2.3 million! In addition to planting seedlings this year, we laid 26,000 vegetation mats in the areas that were planted. Think of vegetation mats as tarps for planting. The purpose of these mats is to keep the grasses, weeds, and other bushes from growing over the new seedlings and hindering their growth. We also plan to survey 1,258 acres of areas planted in previous years to ensure our planting is successful; if the surveys show re-planting not to be successful for any reason, these areas will need to be re-addressed.

In addition to the planting program, work continues in Kodiak on our 17(b) easement marking project with the Bureau of Land Management. The intent of this project is to mark the GIS coordinates and map all 17(b) easements that run on Leisnoi property in the Chiniak area. Our goal is to have all easements clearly marked to diminish any confusion about where those public use easements lie on Leisnoi land.



Shareholder "How To" - Gift Your Leisnoi Stock

To gift your Leisnoi Stock, please complete the *Gift Application for Shareholder and for Recipient*, these forms are available at leisnoi.com/shareholders/forms. Eligibility to gift your stock:

- The "Gifto" (person gifting stock) must be 18 years of age or older; and
- A Shareholder may not gift shares if they are under a custodianship, guardianship, or court order for divorce or child support; and
- The "Giftee" (person receiving stock) must be Alaska Native and a lineal Descendant of an Alaska Native who is a child, grandchild, great grandchild, niece, nephew, brother or sister.

You will also need the following **documentation** to complete the "Inter Vivos" Gift of Stock transfer the following documentation must be submitted with your application:

- Original Birth Certificate (showing lineal descendency)
- Original marriage certificate(s) (if name is different than listed on the birth certificate)
- New Shareholder Record Information form & W-9
- If Giftee (recipient) is a minor child a *Consent to Appointment as Custodian for ANCSA Stock* is also required.

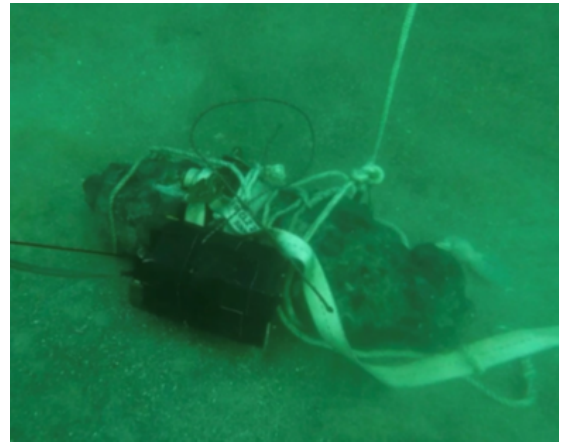
