Although Leisnoi is not required by law to abide by the State's proxy regulations, 3 AAC 08.300, et. seq., due to its size, the Board has decided to comply with the State proxy regulations as a matter of Board policy to ensure fair elections. Information provided by nominees will be used by the Board of Directors and Nomination Committee as it considers candidates for inclusion on the Board-endorsed slate. For both Board-endorsed candidates and candidates running an independent campaign, the information will be used to provide Shareholders information about candidates in the proxy materials.

Shareholders who are running for the one three-year term seat can be listed on the Board's proxy and have their information included in the Board's proxy materials.
